TERMS & CONDITIONS FOR WHOLE METAGENOME SEQUENCING AND ANALYSIS OF RUMEN SAMPLES USING ILLUMINA NEXTSEQ 500 PLATFORM (ANNEXURE A) FOR THE COLLEGE OF VETERINARY SCIENCE & A.H., R.K.NAGAR, WEST TRIPURA, AGARTALA DURING THE YEAR 2016-17.

Notice inviting tender (NIT) will be received by speed post/Registered Post/Courier services in sealed cover addressed to the "Principal, C. V. Sc & A.H. Government of Tripura, R.K.Nagar, Agartala, Tripura" **on or before 4 P.M. of 24.09.2016**. NIT received after the aforesaid date and hours shall be rejected. The Principal, C. V. Sc & A.H. shall not remain responsible for any postal delay. Tenderers are requested to provide detailed address along with phone, Fax Number and S.T.D code number for communication.

- 1) The cost of blank tender form is Rs. 200/- to be paid in the form of DD in favour of Principal, C. V. Sc & A.H. Government of Tripura, R.K.Nagar, Agartala, Tripura payable at Agartala.
- 2) On the top left side of the sealed tender N.I.T number, date, due date of opening should be mentioned. Tenders will be opened on the next working day of last date of receipt, if possible. Tenderer or their representative may remain present at the time of opening of the tender.
- 3) The interested bidders/tenderer shall submit the bids in 2 parts, i.e. 'Technical Bid (A envelope) and 'Financial Bid' (B envelope). The 2 bids A & B envelopes should be put in 2 separate sealed envelopes, indicating clearly on the cover as technical bid and other one is the financial bid. The 2 envelopes shall be placed inside a large sealed cover and the same may be submitted.

The technical Bid shall contain all details regarding the items offered by the bidder, compliances of terms and conditions, submission of documents, products catalogues & earnest money etc. In other words everything except the rate offered. **The Financial bid** shall contain only the rate offered by the bidder. The technical bids will be opened first and the bidder will be short listed on the basis of fulfillment of requirements as per terms & conditions. Thereafter, financial bids of only short listed bidders will be opened and **the lowest bidders will be selected and selection of item is subject to recommendation of the technical committee constituted by the Principal, C. V. Sc & A.H.**

- 4) While quoting rate, the tenderers must mention the Serial No. of the item of tender lists as, provided by the College only along with tender. Items should be supplied by

the authorized local distributor/dealers/agency/suppliers of manufacturing firm of whole metagenome sequencing and analysis of Rumen Samples (Annexure A) and/or Chemicals, Plastic wares and other miscellaneous items (Annexure B) & **the cost should be mentioned in Indian currency i.e. Indian Rupees.**

- 5) As the item is clearly divisible and distinguishable, the successful firms/ tenderers shall be selected on the basis of the lowest cost of the each item.
- 6) The supply has to be executed within 45 (Forty five) days from the date of issue of the supply order. In case, failure of supply the ordered item/items in full within stipulated period, both the Earnest money & Security deposit money are likely to be forfeited without further correspondence.
- 7) 5% of the value of ordered quantity shall have to be deposited by the Firm / supplier as Security deposit Money in the shape of D-Call from any Nationalized Bank in India within 10 days from the date of issue of the supply order which will be released after 1 (One) year, if full supply is completed within the stipulated period.
- 8) V.A.T. & Income tax will be deducted from the bill as per Government rules.
- 9) In case of tenderers whose rates are accepted, as per terms & conditions of the tenderer shall duly execute the supply.
- 10) The rates should be quoted both in figures and words clearly. V.A.T. will be charged extra as per Govt. Rule. The rate should be quoted in Indian currency only.
- 11) The supply order will be issued once/at a time or in phased manner as per requirement.
- 12) The lowest rate quoted by the tenderer will be determined on the basis of comparison of basic rate (i.e. excluding VAT).
- 13) The following self certified/self attested documents should be submitted along with the tender:-
 - (A). Up to date Tax Clearance Certificate (T C C): which will include: -
 - 1) V.A.T. Registration certificate
 - (ii) V.A.T. Clearance Certificate (Sale tax clearance)
 - (iii) PAN Card.
