Tender will be received in sealed cover addressed to the "Director of Animal Resources Dev. Dept. Govt. of Tripura, P.O. - Kunjaban, P. N. Complex, Agartala - 799006, Tripura by Speed post/Registered post/Courier services only "on or before **4 p.m. of 30.04.2016.** Tenderers should provide detailed address along with phone, Fax Number and S.T.D code number for communication. Tender received after the aforesaid date and hours shall be rejected. The Director of Animal Resources Dev. Dept. shall not remain responsible for any postal delay.

- (1) On the top left side of the sealed tender enquiry number, date, due date of opening should be mentioned. Tenders will be opened on the next working day of last date of receipt, if possible. Tenderer or their representative may remain present at the time of opening of the tender.
