



The Chief Executive Officer, Tripura Livestock Development Agency reserves the right to accept or reject any tender without assigning any reason.




The terms and condition for Annual Maintenance Contract (AMC) of liquid nitrogen producing plant (Plant no-5 and Plant no- 6) including voltage stabiliser during the year-2018-19.(2 nos)

- 1) The tenderer shall have to deposit an amount Rs 5000/- (Rupees Five Thousand) only as earnest money in the shape of 'Deposit at Call' in favour of the Chief Executive Officer, Tripura Livestock Development Agency, Astabal, Agartala.
- 2) The successful tenderer will deposit 10% of the ordered value as security money in the shape of 'Deposit at Call' in favour of the Chief Executive Officer, Tripura Livestock Development Agency, Astabal, Agartala
- 3) Tender will be received by speed post/ registered post/ courier service only in sealed cover addressed to the Chief Executive Officer, Tripura Livestock Development Agency, Astabal , Agartala . Tender received after aforesaid date shall be rejected. The Chief Executive Officer, Tripura Livestock Development Agency (TLDA) shall not be responsible for any kind of postal delay.
- 4) The tenderer are requested to provide details of address along with the phone/Fax number & STD code for communication. On the top left side of the sealed tender enquiry number, date, due date of opening and address of the tenderer should be mentioned.
- 5) The tenderer should have the experience of AMC undertaken at least in 10 nos of organization which is having the same technology. The certificate needs to be attached.
- 6) There will be 2 nos of bid - one is **Technical Bid** and other one is **Financial Bid** . Both the bid should be enveloped separately and sealed properly mentioning the technical bid and financial bid on them . Thereafter, both the bid will be placed in large envelop mentioning details of address of the bidder /contact numbers etc on it. Only the technically qualified bidder will be illegible for financial bid.
The decision of the Technical committee of the Tripura Livestock Development Agency is final.
- 7) There will be minimum two nos of preventive maintenance visit at reasonable spaced duration and unlimited break down maintenance visit as & when necessary.
- 8) The tenderer shall be responsible for supply of the spare parts including the spares of cryogenerator for preventive maintenance and break down services. The cost of spare parts will be charged extra.
- 9) The respond time is maximum 72 hours (on call to reach at work site and take up the job) . In case of delay in supply /job taken on the part of the bidder a penalty at the rate 0.5% per week to maximum 10% of the ordered value will be charged for the period of delay and installation. This penalty will be deducted from the security deposit.
- 10) The payments will be made in two half yearly equal installment - 1st after satisfactory completion of 6 month and 2nd after satisfactory completion of AMC period.
- 11) The validity of the contract is one year from the date of issue of the work order.
- 12) The contract may be terminated at any time by either party on 30 days advance notice. In that case established norms of the tender will be followed.
- 13) The rate should be typed and quoted both in figure and words. The rate should be quoted in Indian currency. The quoted rate should be without taxes.
- 14) The TLDA will not consider any enhancement of rate within the validity period of contract except imposition of any levy. Such request will lead to cancellation.
- 15) The following self attested documents should be submitted along with the tender:-
 - i) PAN card .
 - ii) GST certificate.
 - iii) Professional tax clearance certificate.
 - iv) Registration of the firm.
- 16) The CEO, TLDA Astabal, Agartala reserve the right to accept or reject any/all quotation without assigning any reason thereof & tender may be accepted or rejected in part or in whole.
- 17) Any legal interpretation is restricted to the state of Tripura only.
