TERMS & CONDITIONS FOR PURCHASE OF BOOKS FOR THE COLLEGE OF VETERINARY SCIENCES & A.H., R.K. NAGAR WEST TRIPURA DURING THE YEAR 2024-25.

Notice inviting tender (NIT) will be received by speed post/Registered Post/Courier services only in sealed cover addressed to "The Principal, C. V. Sc & A.H. Government of Tripura, R. K. Nagar, West Tripura Pin-799008" on or before 4 P.M. of 02.11.2024 NIT received after the aforesaid date and hours shall be rejected. The Principal, C. V. Sc & A.H. shall not remain responsible for any postal delay. Tenderers are requested to provide detailed address along with phone, Fax Number and S.T.D code number for communication.

- 1) The cost of blank tender form is Rs. 300/- (Rupees three hundred, Non-refundable) which may be paid in the form of DD of any Nationalized bank in favour of "The Principal, C. V. Sc & A.H. R. K. Nagar, West Tripura" payable at 'Agartala'. The tenderers who will use downloaded form from the website also shall have to pay the cost of the tender form Rs. 300/- (Rupees three hundred, Nonrefundable) only separately in the form of DD of any Nationalized bank in the name of Principal, College of Veterinary Sciences & Animal Husbandry, R.K. Nagar, payable at Agartala. Downloaded tender form received without DD of Rs. 300/- shall be rejected. No blank tender form shall be supplied either by post or courier to the tenderers. While quoting the rate, the tenderer must mention the serial no of the books as per list (at Annexure A) provided by the college along with tender.
- 2) On the top left side of the sealed tender N.I.T number, date, due date of opening should be mentioned. Tenders will be opened on the next working day of last date of receipt, if possible. Tenderer or their representative may remain present at the time of opening of the tender.
- 3) The interested bidders/tenderer shall submit the bids in 2 parts, i.e. 'Technical Bid (A envelope) and 'Financial Bid' (B envelope). The 2 bids A & B envelopes should be put in 2 separate sealed envelopes, indicating clearly on the cover as technical bid and other one is the financial bid. The 2 envelopes shall be placed inside a large sealed cover and the same may be submitted.


The technical Bid shall contain all details regarding the items offered by the bidder, compliances of terms and conditions, submission of documents, products catalogues & earnest money etc. In other words everything except the rate offered. The Financial bid shall contain only the rate offered by the bidder. The technical bids will be opened first and the bidder will be short listed on the basis of fulfillment of requirements as per terms & conditions. Thereafter, financial bids of only short listed bidders will be opened and the lowest bidders will be selected and selection of item is subject to recommendation of the technical committee constituted by the Principal, C. V. Sc & A.H.

- 4) While quoting rate, the tenderers must mention the Serial No. of the item of tender lists as, provided by the College only along with tender. Items should be supplied by the authorized book sellers/distributers/suppliers.
- 5) As the items are clearly divisible and distinguishable, the successful firms/tenderers shall be selected separately for each item.
- 6) The supply has to be executed within 45 (forty five) days from the date of issue of the supply order. In case, failure of supply the ordered item/items in full within stipulated period, both the Earnest money and security deposit money are likely to be forfeited without further correspondence.
- 7) G.S.T & Income tax will be deducted from the bill as per State Government rules.
- 8) In case of tenderers whose rates are accepted, as per terms & conditions of the tender shall duly execute the supply.
- 9) The rates should be quoted both in figures and words clearly. GST will be charged extra as per Govt rule. The rate should be quoted in Indian currency only.
- 10) The supply order will be issued once/at a time or in phased manner as per requirement. Quantity may increase or decrease depending on requirement.
- 11) The lowest rate quoted by the tenderer will be determined on the basis of comparison of basic rate (i.e. excluding GST).




