Officer to join in duties in the existing place of posting immediately and explain as to why appropriate action shall not be taken against him for such un-authorized absent from duties and directed to reply to the authority within 15 days from the date of issue of this letter failing which action will be taken as per Rule. But, Dr. Ankur Debnath neither join in his Govt. duties nor reply to the letter of the authority.

Whereas the Dy. Director of ARD(REPBF), Nalkata issued a notice vide No.F.E.78/DD/ARDD/REPBF/NLK/2016/157-58 dated 18.07.2020 to Dr. Ankur Debnath requesting him to resume in Govt. duties and to explain reason behind his unauthorized absent and the copy of the notice was also forwarded to the Officer-in-charge, Agartala East Police Station, Agartala, West Tripura to serve the notice to his Home Address, as recorded in Service Book of Dr. Ankur Debnath. But, the O/C. Agartala East Police Station, Agartala, West Tripura could not serve notice.

Now, therefore, Dr. Ankur Debnath is hereby asked to report in his Govt. duty on or before 31st December,2024 and explain the reasons behind such long unauthorized absence w.e.f. 29.05.2019 for granting as last opportunity to Dr. Debnath.
