6. Eligibility criteria:

- The candidates (Indian citizen) should be registered under the State Veterinary Council or VCI, New Delhi. However, such registration is not applicable for the Agronomy post.
- The higher professional qualification of the candidate should be in the relevant subject (M.V.Sc./ Ph.D.) with a basic degree in Veterinary Science. However, for the Agronomy post higher professional qualification of the candidate should be in Agronomy (M.Sc./ Ph.D) with a basic degree in Agricultural Science.
- For the contractual post of Professor & Associate Professor only, the regular or retired Professor & Associate Professor from recognized Agricultural & Veterinary University/College may apply.
- For the post of Professor the candidate must have Ph.D. degree in the relevant subject with minimum 10 years of experience in teaching/research including experience as Associate Professor of minimum 3 years. However, preferences will be given to the candidate having an experience as Professor.
- For the post of Associate Professor the candidate must have Ph.D. degree in the relevant subject with minimum 8 years of experience in teaching/research. However, preferences will be given to the candidate having an experience as Associate Professor.
- For the post of Assistant Professor the candidate must have M.V.Sc. Degree (M.Sc. Degree for the post of Agronomy) with NET or Ph.D. degree in the relevant subject.
- For selection of contractual Professor, Associate Professor & Assistant Professor, maximum age limit is 68 years, 65 years and 40 years respectively, on the date of appearing walk-in -interview.
- The eligible candidate having PRTC (Permanent Resident of Tripura Certificate) will be desirable for the post of Assistant Professor, Associate Professor and Professor.

7. Selection Procedure:

- a) Advertisement for Walk-In-Interview will be published in local and national dailies and widely circulated in newspaper through the Director, ICA; ardd.tripura.gov.in website through the IT Cell, ARDD.
- b) The intending candidates should bring & produce the application form, addressed to the Director, ARDD, Tripura as per prescribed form, duly filled in (See <https://ardd.tripura.gov.in/> website) along with all necessary testimonials in original and self attested photocopies as mentioned in the check list at the time of appearing in the interview board.
- c) To make the merit list of the candidates, appearing in the interview, a Recruitment (Interview) Board will be constituted to select the candidates for appointment to the all faculty post on contractual basis.
- d) The selection of the candidate will be on the basis of academic performance index (API) which will carry 85% marks and by personal interview (15% marks). Marks totaling scored in API and in personal interview will be considered for preparation of the merit list. In-case the candidate selected in the interview do not join after receiving offer letter in due course of time period, the next candidate from the panel will be offered for engagement.
- e) For API scoring of Professors & Associate Professor, **Table no. 2 of UGC Regulation, 2018** may be followed, whereas for API scoring of Assistant Professor, **Table no. 3B of UGC Regulation, 2018** may be followed. For comparing the API score among the candidates, the percentile system will be followed.
- f) In the recommendation list, merit position of the candidates securing equal marks will be finalized as per their seniority of age and in case of candidates securing equal marks in aggregate and also of the same age will be decided on the basis of percentage of marks obtained in the minimum educational qualification prescribed. The same procedure is to be followed for preparing waiting list of candidates, if there be any.
- g) The decision of the Recruitment Board shall be considered final in making the merit list of the candidates, based on the criteria of selection.
- h) The candidates will be selected by the authority from the merit list.
