## **TERMS AND CONDITIONS**

## Terms and Conditions for submission of quotations are as follows:

- 1. The vehicle is to be fitted with kilometers reading meter in good running condition, defect K.M reading meter is to be replaced / repaired by the owners.
- 2. In case of any Damage/ Break down of the vehicle the owner have to repair the same at own cost and risk.
- 3. Sitting capacity of Volvo/Star/Sml AC bus will be within the minimum 35 seat capacity.
- 4. The driver with valid driving license shall be arranged by the owner at his own cost. The driver with running condition vehicle id to report at place of duty in exact time.
- 5. The driver should maintain a logbook in the standard Performa. All journeys shall be recorded in the logbook and obtained signature of the officials using the vehicle.
- 6. The number of Vehicles may increase or decrease. Payment will be made only for those days of which the services of the vehicle have been utilized and for respective total Kilometers runs.
- 7. The vehicle shall be supplied in stipulated date mention in short quotation notice. It will normally run within the jurisdiction of West District. But incase of necessary the vehicle may be used beyond West District and within Tripura.
- 8. The agreement period of the vehicle may be extended / reduced if felt necessary. Cost of parking charges, entry fee etc. will be the responsibility of service provider.
- 9. Fuel / Lubricants / Maintenance of vehicle including pay and allowances of the driver etc. have to be borne by the owners of the vehicle.
- 10. If the vehicle remains off in the road, alternative arrangement i.e. another vehicle will have to be placed by the owner for which no extra payment will made, If no alternative arrangement is made within 1(one) hours, necessary deduction @ Rs. 500/- (five hundred) per hour will be made from the bill and the contract may be discontinued by the In-Charge.
- 11. In case of failure of placement of vehicle on any day to the concerned office resulting in hiring of another vehicle by the Department, the difference of cost will be deducted from the bill.
- 12. The number of vehicles may increase or decrease. However dates may be altered if emergency arises.
- 13. The initial and final K.M reading shall be taken at the particulars place of duty and no K.M measurement will be given for journey to and fro the owners garage.
- 14. The vehicle shall be in extremely good running condition. The test will be conducted by the authority before placing the work order at the tenders own risk & own cost, if the result of rest run is found not satisfactory to be cancel.
