**TERMS AND CONDITIONS**

- 1) The tender will be floated in two parts- 1) Technical bid & 2) financial bid. Accordingly two folders will be created at the bidder login (<https://tripuratenders.gov.in> ). The bidder should upload technical document to technical folder and the financial document in financial folder only.  
The technical details should also be uploaded in the technical folder.

**Note:-** If the financial document is uploaded in the technical folder or vice versa , the bids will be rejected. In addition technical document can also be saved in 'My Account/ My Document' folder.

- 2) The interested bidder should furnish the bid in two parts namely Technical bid and financial bid ( BOQ).
- 3) The tender shall not be accepted from any bidder who has been blacklisted /banned /debarred either by the tendering inviting authority , Government of Tripura or any other state / Central Government and its procurement agencies. A declaration by the Tenderer must be submitted in this regard.
- 4) The concerned company/ bidder whose product has been declared as of spurious or adulterated quality and any criminal case is filled and pending in any court shall not be eligible to participate for those particular products in the tender. Similarly convicted firm/company shall also not be eligible to participate in the tender.
- 5) The bidder will deposit Rs.10,000/ ( Rupees Ten Thousand ) as Earnest Money Deposit ( EMD) in the shape of D-call in favour of the Chief Executive Officer , Tripura Livestock Development Agency, Astabal, Agartala.
- 6) The successful bidder will deposit 5% of the ordered value as Security Money Deposit ( SMD) after the contract has been awarded in shape of D-call in favour of the Chief Executive Officer, Tripura Live stock Development Agency Astabal, Agartala. The security money will be released after the completion of the full and satisfactory supply.
