



TERMS AND CONDITION FOR THE PURCHASE OF 2,00,000 LITERS OF LIQUID NITROGEN IN PHASE MANNER AS PER REQUIREMENT ALONG WITH TRANSPORTATION TO DHARMANAGAR (TRIPURA NORTH DIST) , R.K.NAGAR (TRIPURA WEST DIST) AND UDAIPUR (GOMATI DIST.) DURING THE YEAR 2019-20.


- 1) The e-tender will be submitted addressed to the chief Executive officer, Tripura livestock Development Agency, Astabal, Agartala on or before **02/09/2019, till 4 P.M.** Tender received after aforesaid date shall be rejected. The chief Executive Officer, Tripura Livestock Development Agency (TLDA) shall not be responsible for any kind of delay.
- 2) The tender are requested to provide details of address along with the phone/Fax number & STD code for communication. On the top left side of the sealed tender enquiry Number, date, due date of opening and address of the tenderer should be mentioned.
- 3) The tenderer shall have to deposit an amount of Rs.**5000/-**(Rupees Five thousand) only as Earnest Money for the item in the shape of 'Deposit at Call' or Demand Draft on any Nationalized Bank at Agaartala in favour of the CEO, TLDA, Astabal, Agartala . No other deposit will be entertained. Registered Co-operative(s)/Societies and State/Central units permanently registered with NSIC are exempted from Earnest money if an authentic documentary proof is provided.
- 4) The tenderer should submit the tender in two parts viz. "Technical Bid" and 'Financial Bid' in the "Technical Bid" the tenderer would furnish the following certificate/self attested documents.
 - a) 'Explosive License' enabling him/her to deal with Liquid Nitrogen, b) a list of clients to whom the tenderer supplied LN₂ c) Professional Tax Clearance certificate & PAN/TAN Certificate, d) Income tax certificate, e) GST registration Certificate f) all the technical details regarding purity of LN₂ . In this respect, the manufacturing firm must have a quality control laboratory and it should be inspected time to time by the competent authority and the latest report is to be attached. A certificate to this affect should be attached. G) All other relevant documents, if any.
- 5) In the "Financial Bid" the rate of Liquid Nitrogen including transportation charge F.O.R Dharmanagar, Tripura, R.K.Nagar (Agartala) and Udaipur (Gomati) separately should be mentioned clearly and **GST extra as applicable** .
- 6) The successful bidder shall have to deposit security money for Rs. 1.00 Lakh (Rupees One Lakh) only in favour of the CEO, TLDA in the shape of 'Deposit at Call' (D-Call) within 15 days communication from this end regarding acceptance of rate. The security money will be released after completion of the total supply.
- 7) The Liquid Nitrogen is to be supplied within 15 day from the date of issue of the supply order.

- 8) The Tripura livestock Development Agency will not entertain any enhancement of rate within the validity period of contract except imposition of any levy.
- 9) After acceptance of rate, if any tenderer refuses to carry out the terms of tender and Interested to do the work, his/her security money will be forfeited
- 10) The Earnest money of the unsuccessful tenderer will be returned as soon as possible.
- 11) The rate should be typed and quoted both in figure and words. The rate should also be quoted in Indian National currency. Any erasing or overwriting that may be made in the course of completing the form should be initiated by the tenderer(s) before it is submitted.
- 12) Annual approximate requirement is incorporated in the NIT which is likely to be increased or decreased as per requirement. The supply order shall be issued in phase manner as per requirement.
- 13) The tenderer should sign in all the pages of tender documents.
- 14) The purity of Liquid Nitrogen should preferably be 99.99% i.e. Oxygen content is not greater than 0.5 **ppm** and is free from solid content. However, minimum purity of Liquid Nitrogen should not be less than 99.5% and the supplier should attach a certificate in this respect.
- 15) The CEO, TLDA Astabal, Agartala reserve the right to accept or reject any/all quotation without assigning any reason thereof & tender may be accepted or rejected or rejected in part or in whole.
- 16) Any legal interpretation is restricted to the state of Tripura only.
- 17) Total LN₂ supply to Dharmanagar- 50,000 Ltrs., to R.K.Nagar -1, 00,000 Ltrs. and to Udaipur - 50,000 Ltrs.
- 18) Total 15,000 Ltrs. of LN₂ will be supplied per trip for 12 trips and 10,000 Ltrs. of LN₂ will be supplied per trip for 2 trips.
- 19) The quantity of the LN₂ to be procured may be increased or decreased as per requisition and at the discretion of the authority.
- 20) **VALIDITY OF SUPPLY: – 1 YEAR FROM THE DATE ACCEPTANCE OF RATE.**
