**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor, Tripura is pleased to make rules in the Schedule annexed herewith regarding the method of recruitment for appointment to the post of Statistical Officer/Research Officer (Group-B, Gazetted) under Animal Resources Development Department, Government of Tripura namely :

1. Short title and commencement.

(1) These Rules may be called the Recruitment Rules for the post of Statistical Officer/Research Officer (Group-B, Gazetted) under Animal Resources Development Department, Government of Tripura, 2009.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. The name of the Post(s) shall be specified in Column-1 of the Schedule annexed hereto.

3. Number, classification and scale of Pay.

The number of the said post, its classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 of the Schedule annexed hereto.

4. Method of recruitment, age limit, qualification etc.

The method of recruitment to the said post, age limit, educational qualifications and other matters relating to the said post shall be as specified in Columns 5 to 13 of the said Schedule.

5. Disqualification :- No Person ---

(a) Who has entered into or contracted a marriage with a person having spouse living ; or

(b) Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post :-

Provided that the State Government may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax :-

Where the State Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in the writing and in consultation with the Tripura Public Service Commission, relax any of the provision of these rules with respect to any class or category of persons.



7. Saving :-

Nothing in these rules shall effect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled castes, the Scheduled Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.

At least 3 (three) years, experience in Statistical works in any Government Organization or in an Organized by the Government.
8. Whether age and educational qualifications prescribed for the direct recruitment will apply in the case of promotees. :- i) Age : Not applicable  
ii) Educational qualification : Not applicable
9. Whether Selection post or Non-selection :- Selection post.
10. Period of probation, :- 2(two) years.
11. In case of recruitment by promotion/deputation/transfer grade from which promotion/deputation/transfer is to be made. :- Promotion from the post of Assistant Statistical Officer with experience of at least 5 (five) years in the grade or by transfer on deputation from the Analogous post.
12. If a D.P. C. exists, what is it's composition. :- Not applicable
13. Circumstances in which TPSC is to be consulted in making recruitment. :- As required under the T. P. S. C. (Exemption from consultation) Regulations, 1973.
