DETAILS NOTICE INVITING TENDER (DNIT).

TENDER FOR PROCUREMENT of one UV-Transilluminator UNDER THE DST FUNDED RESEARCH PROJECTS ENTITLED "Molecular Epidemiology and Public Health Significance of Water-borne Cryptosporidiosis in Tripura" FOR THE DEPARTMENT OF VETERINARY PUBLIC HEALTH & EPIDEMIOLOGY (VPHE), COLLEGE OF THE VETERINARY SCIENCES AND ANIMAL HUSBANDRY (C.V.Sc & A.H.), R.K.NAGAR, WEST TRIPURA, FOR ONE YEAR are hereby invited by the Principal, College of Veterinary Sciences & Animal Husbandry, R.K.Nagar, Tripura West, Tripura, from the reputed, resourceful and bonafied authorized Distributors/Dealers/ Manufacturing firms.

TERMS & CONDITIONS

1. Notice inviting tender (NIT) will be received by speed post/Registered Post/Courier services/by hand in sealed envelope to the "Principal, C. V. Sc. & A.H., R.K. Nagar, West Tripura, Tripura – 799008, India", on or before 09-9-2019, 4:00 pm. NIT received after the aforesaid date and hours shall be rejected. The Principal, C. V. Sc. & A.H. shall not be held responsible for any postal delay. Tenderers are requested to provide detail address along with phone, Fax Number and S.T.D code number for communication.

The cost of tender form is Rs. 500/ (Rupees Five Hundred, non-refundable)- which may be paid in the form of DD of any nationalized Bank in the name of **Principal, C. V. Sc. & A.H., R.K.Nagar, West Tripura** payable at **Agartala**.

- i. On the top left side of the sealed tender N.I.T number, date should be mentioned. Tenders will be opened on the next working day of last date of receipt, if possible. Tenderer or their representative may remain present at the time of opening of the tender.
- ii. The interested bidders/tenderers shall submit the bids in 2 parts, i.e. 'Technical Bid ("**A**" envelope) and 'Financial Bid' ("**B**" envelope). The 2 bids A & B envelopes should be put in 2 separate sealed envelopes, indicating clearly on the cover as technical bid and other one is the financial bid. The 2 envelopes shall be placed inside a large sealed cover and the same may be submitted.

The technical Bid shall contain all details regarding the items offered by the bidder, compliances of terms and conditions, submission of documents, products catalogues & earnest money etc. In other words everything except the rate offered.

The Financial bid shall contain only the rate offered by the bidder.

The technical bids will be opened first and the bidder will be short listed on the basis of fulfillment of requirements as per terms & conditions and **recommendation of the technical committee constituted by the authority.** Thereafter, financial bids of only short listed bidders will be opened and **the lowest bidders will be selected.**

2. The rates should be quoted both in figures and words clearly. **The rate should be quoted in Indian currency only.**
3. The supply has to be executed within 45 (forty five) days from the date of issue of the supply order. In case , failure of supply of the ordered item/items in full within stipulated period, both the Earnest money & Security deposit money are likely to be forfeited without further correspondence.

4. G.S.T. & Income tax will be deducted from the bill as per Government rules as applicable.
5. In case of tenderers whose rates are accepted, as per terms & conditions of the tender, shall duly execute the supply.
6. The lowest rate quoted by the tenderer will be determined on the basis of comparison of basic rate (i.e. excluding G.S.T.).
7. The following self certified/self attested documents should be submitted along with the tender:-

(A) Up to date Tax Clearance Certificate which will include: -

- (i) G.S.T. Registration certificate.
- (ii) G.S.T. Clearance Certificate (Sale tax clearance).
- (iii) PAN Card.

(B) Other Certificates

(i) Up to date valid Trade License certificate of authorized local Distributors / stockiest / dealers / agencies / suppliers of manufacturing firms (Authorized in case of authorized Distributor-cum-tenderer.

8. **Earnest money (E/M) for an amount of Rs. 3300.00/-** (Rupees three thousand and three hundred) only shall have to be deposited along with the tender as fresh deposit at Call (D-Call) /Bank Draft of any nationalized Bank of India, drawn in favour of the Principal, College of Vety. Science &A.H., R.K.Nagar payable at Agartala. In case of un-successful tenderers, the Earnest Money deposit (EMD) will be released after finalization of the tender, while in case of successful tenderers / suppliers the Earnest Money (EMD) will be released after successful completion of supply.
9. EMD/SMD shall not be applicable in case of Govt. organization/Public Sector undertaking for that case documentary evidence to be submitted to that effect.
10. Price quoted should be met F.O.R. Door delivery and installation also (if required in case to case basis) in good condition to THE DEPARTMENT OF VETERINARY PUBLIC HEALTH & EPIDEMIOLOGY (VPHE), College of the Veterinary Sciences & A.H., R.K. Nagar, West Tripura, pin-799008.
11. The supplier, who is not a manufacturer or who quoted rate for the product in favour of the manufacturer shall furnish a letter of authority from their behalf. Such supplier/tenderer shall also furnish an undertaking that in the event of acceptance of the rate he will supply the products of the manufacturer for which he quoted the rate.
12. No. Insurance charge is admissible and the successful tenderer/supplier will be responsible for any breakage, damage and loss in transit on the way to destination.
13. Any default or breach of contract by the suppliers will be subject to forfeiture of earnest money/security money & will be considered as blacklisted /delisted for participating future tender as per discretion of the Principal, College of Vety Sciences & A.H., R.K. Nagar, West Tripura.
