

NOTICE INVITING TENDER

Sealed tender contained rates in plain paper addressed to the Dy. Director of Animal Resources Development, R.K.Nagar Farm Complex, are invited on behalf of the Governor of Tripura from experienced carrying contractor for transportation /carrying/loading and unloading of prepared ration/Calf Growth Meal/ feed ingredients etc for livestock and birds from Feed Mixing Plant, R.K.Nagar Farm Complex to different Institutions/Govt. Farms of the Department throughout the State of Tripura w.e.f 1st January, 2018 to December, 2018. Every carrying contractor should have at least 2(two) nos of big truck & 1(One) No Mini truck of his own or his legal family member/ partner with documentary proof for the purpose of placing the said numbers of vehicles at a time if necessary at the time of dispatching the feed ingredients/prepared ration/Calf Growth Meal etc. The sealed tender will be received at the office of the Dy.Director of ARDD(FC), R.K.Nagar upto 3 p.m. of 15th December'2017 and same will be opened at 1 P.M. on 16th December' 2017 if possible in presence of the tenderers or their authorized representative **if remain present. No tender will be received other than registered post/courier service.** Tenders received later than the scheduled time and date due to postal delay and or whatsoever will not be accepted. The Director, ARDD reserves the right to reject any/all the tenders without showing any reason thereof.

Detailed terms and condition of the tender will be available in the Vehicle Section, O/O the Dy. Director of ARDD(FC), R.K.Nagar Farm Complex on all working days.

**TERMS AND CONDITIONS OF THE TENDER FOR TRANSPORTATION OF FEED/CALF GROWTH MEAL (C.G.M.), FEED INGREDIENTS FROM R.K.NAGAR TO DIFFERENT OUTLETS OF THE STATE DURING THE PERIOD
FROM JANUARY, 2018 to DECEMBER, 2018.**

- 1) The tenderer should submit attested photocopy of citizenship certificate & aadhar Card as a proof of citizen of India.
- 2) Attested copy of up-to-date income tax certificate, PTCC, road permit/ valid registration number of the vehicle etc. should be enclosed with tender papers. But original copies may be produced on demand at the time of opening of the tender.
- 3) Erasing, over-writing shall not be allowed in any case.
- 4) Each page of tender should be signed by the tenderer. If tenderer is in the partnership form, each partner should sign the tender paper in each page.
- 5) The tenders must deposit an amount of **Rs.10,000/-** only as earnest money in the shape of **Deposit at Call** in favour of the Dy. Director, ARDD(FC), Govt. of Tripura, R.K.Nagar Farm Complex, which may be released to the un-successful tenderer after receiving prayer from them & for the successful tenderer it may be released after depositing of security money.
- 6) The tenderers should put the rate per km/per quintal inclusive of all taxes.**
- 7) The tenderer should put the rate for per kg loading.**
- 8) The tenderer should put the rate for per kg unloading separately.**
- 9) The successful tenderers shall have to deposit an amount of **Rs.50,000/-** only as security money in the shape of "**Deposit at call**" in favour of the Dy. Director of ARD(FC), Govt. of Tripura, R.K.Nagar Farm Complex.
- 10) Successful tenderer/(s) shall have to execute an agreement bond within the period of 7 days from the date of receipt of acceptance on a non judicial stamp @ **Rs.20/-** only.
- 11) After acceptance of the rate successful carrying contractor shall be liable for transportation of **prepared feed/Calf Growth Meal (C.G.M.)/feed ingredients** etc. as per order issued by the DD(FC), R.K.Nagar. In case, refusal of the same order, the security money shall be forfeited.
- 12) Accepted tenderer is/are responsible for any loss, breakage/damage of feed items during transportation and shall be liable to pay the cost of damaged items.
- 13) The authority reserves the right to accept or reject any tender without assigning any reason thereto.
- 14) Accepted rate will be followed upto six months from the date of acceptance which may be extended for a further period of six months if considered to be required.
- 15) Prepared feed/C.G.M./feed ingredients etc. should be transported to the point of destination within 24 hours from loading point i.e. R.K.Nagar Farm complex/other Farms/organizations.
- 16) The undersigned reserves the right to deduct GST and income tax as per norms of the Govt. from the bill.
- 17) Any legal interpretation is restricted to the State of Tripura, only.
